1. DELHI PUBLIC SCHOOL SHIKOHABAD is permanently affiliated to State Board (U P Government) for Nursery to Grade-8 and it is affiliated to CBSE, New Delhi up to SENIOR SECONDARY LEVEL. Its Period of affiliation is 01.04.2025 to 31.03.2030 vide CBSE Affiliation Grant Letter No: CBSE/2132006/EX-02593-2526/2025-26/ Dated: 27/04/2024. Its affiliation no. is 2132006. We would like to reassure all parents that the matter is sub judice, and the Trust remains committed to ensuring continuity, stability, and the best interests of the students. We will continue to abide by all directions issued by the Hon'ble Court.
We appreciate your continued trust and support.
5. The Trust utmostly believes that the decision of high court will be in favor of the school. In case, if the orders of the DELHI HIGH COURT will not be in the favor of continuing with the name of DPS in future, then we assure you that the school will get another NATIONAL/INTERNATIONAL Branded Franchise and the school will be running as it is, as the THE SCHOOL is permanently affiliated.
6. Its facilities, teachers, quality of education, academic, sports and cultural activities along with all other features will be the same.
